Boat had several new keels in the late 90's before my ownership, all basic shape and weight changes. In 2013 I modified the boat by filling in the mast hollow above the hounds, added laminate to the entire mast, added mast head spinnaker halyards, added a sprit, removed spinn. Pole, changed keel and ballast installing a T keel and a bulb, which replaced the standard deep fin. Removed about 3500# of internal ballast. Reduced jib to 131% and reduced E. NO CHANGES IN 2017.

In July 2016 added 712lbs of lead to the leading edge of the keel fin.
